1:00 PM – 3:00 PM: **Major Nonprofit Accounting Changes Effective This Year:** Laurence Scot, MBA, CPA, Co-Founder and Co-Managing Partner, Skody Scot & Co., CPAs

Within the last few years a number of major accounting and reporting revisions have been approved by the Financial Accounting Standards Board (FASB) that will affect every nonprofit organization in the country large or small. These are the first significant changes in over 25 years. Some of these changes will have a major impact on how an organization prepares their financial statements. Others have to do with accounting for: revenue with customers, contributions/grants received and made, and operating leases and will have a major effect on an organization’s net income. This workshop will cover these major revisions in a precise, clear and an easy-to-understand manner.
